

Naloxone in the workplace?


Even though heart disease isn't a common workplace hazard, AEDs are typically installed for employee safety. Since opioid overdoses can occur just as unexpectedly – and be just as deadly – as cardiac arrest, employers should assess the risk of on-site employee overdose based on factors like the nature of work, employee demographics, and visitor frequency.


This safety consideration is especially relevant given the extent of the opioid crisis in the United States today. Now is the time for employers to seriously consider including [naloxone](#), a relatively inexpensive opioid overdose reversal medication, in workplace first-aid kits to support the overall well-being and safety of their employees.
